ISOSS Holds Its 22nd International Conference on Statistical Sciences (ICSS-22)

The 22nd International Conference on Statistical Sciences (ICSS-22) was jointly organized by Islamic Countries Society of Statistical Sciences (ISOSS) and Department of Mathematics and Department of Statistics, University of Sargodha, Pakistan on December 15-16, 2025. The theme of the conference was: **“Advancing Mathematical and Statistical Sciences in the Era of AI, Big Data and Uncertainty”**.

A total of 95 research papers were submitted, out of which 67 papers were presented during the conference. The scientific program included 16 international speakers and 12 national speakers, demonstrating strong national and international participation. Special emphasis was placed on emerging and contemporary research domains such as AI-driven statistical modelling, advanced machine learning, Bayesian deep learning, fractional calculus, computational mathematics, climate and reflecting current global research trends. The conference witnessed active participation from scholars representing the United Kingdom, China, Czech Republic, Australia, Bangladesh, Turkey, Mexico, Saudi Arabia, United Arab Emirates, Qatar, and Oman.

Islamic Countries Society of Statistical Sciences acknowledges and expresses its appreciation to the sponsors of ICSS-22 for their generous support. A contribution of PKR 300,000 was made by **Dr. Muhammad Hanif Mian**, President ISOSS and PKR 500,000 was provided by the Higher Education Commission (HEC), Pakistan.

In a business session of the conference, the theme of upcoming Islamic Countries conference was reconsidered and it was decided that the theme will be **“The Role of Statistics and Data Science in the Era of Artificial Intelligence.”**



The 16th Islamic Countries Conference on Statistical Sciences (ICCS-16)

Sixteenth Islamic Countries Conference on Statistical Sciences (ICCS-16) is expected to be held at Qatar University, Doha, Qatar. **Prof. Dr. Muhammad Hanif Mian**, President, ISOSS has assured that the matter is being finalized with Qatar University authorities and the conference will positively be held in Doha, Qatar, later this year.

Review of ISOSS Constitution

In Business Session of ICSS-22, the need to revisit and update the ISOSS Constitution was discussed. The house was informed that **Prof. Dr. Shahjahan Khan** and **Prof. Dr. Nazeer Khan** had already undertaken preliminary work on proposed constitutional amendments. The matter was discussed, and it was agreed that these proposed amendments would be further reviewed and refined. Accordingly, a Constitution Review Committee was constituted as under:

The above committee will examine the existing Constitution and submit finalized recommendations.



Elections for the Posts of President, Secretary and Setting Up of ISOSS Executive Board

The eligible voters, for that purpose, will be the registered members of the Society as defined in the constitution. Once the constitution is revised in the light of recommendations of the committee mentioned above and the voters list is finalized the elections will be held in the business session of upcoming Islamic countries conference, hopefully in Qatar, later this year.

Dr. Abdullah Bin Omar Nasseef

**Patron-in-Chief ISOSS,
passed away on October 12, 2025**

Dr. Abdullah Naseef was a kind hearted person. He visited Pakistan several times on the invitation of Late Professor Dr. Munir Ahmad. He accompanied ISOSS delegation to Mian Muhammad Nawaz Sharif, then CM Punjab, at Chief Minister's Office. On his request CM allotted a piece of land for ISOSS Headquarters, Lahore i.e. ISOSS House. He also travelled to Pakistan in stone laying plaque ceremony of ISOSS House in 1991. He was always there for any help required to ISOSS. ISOSS members are obliged to acknowledge his services rendered to Society and Muslim Ummah at large.
